

# Individual Family Commitment Form

## School Tuition 2011-2012

Please note the following:

- Although the cost to the Parish to educate a child in the 2010-2011 school year will undoubtedly be higher, it was decided to limit the “full cost tuition” to \$4400. This is a \$50 increase over last year, to help cover the cost of lunch room monitors. (Half-day Kindergarten tuition remains at \$3,100.)
- The parents are expected to pay the full cost **unless prevented by serious financial need**, in which case the parish is willing to pay up to 15% of the tuition. This is the same as in the last four years. This subsidy is available to any school family.
- The individual parent decides how much subsidy, if any, to ask of the parish.
- Beyond the financial aid that is available from the diocese, the Parish has a small scholarship fund that can provide further help to some families. Applications are at the Parish Office, and are handled on a case-by-case basis.
- Please note: The Diocesan Tuition Assistance Application **MUST be filed by April 12** prior to the new school year. The diocese is very strict about this deadline.
- The “registration fee” of \$150 per student, although non-refundable, *is not an additional fee*; it is folded into the full tuition. This completed commitment form, along with a tuition payment or, at least, the registration fee, must be paid in order to process a registration.
- Eligible families can choose a monthly payment schedule, with the expectation that the payments will be complete by the end of February.
